#### CHINASOFT RECEIVES TRUSTED CLOUD SERVICE CERTIFICATION

Recently, the National Data Center Alliance announced the third installment of trusted cloud services certification, and Chinasoft successfully made the list and received the certification for its cloud application RAE.

#### Chinasoft Leads in PaaS Services While Trusted Cloud Certification Standard Increases

"Trusted Cloud Service Certification" is the only national certification that is cloud specific. This certification is co-organized by the Data Center Alliance and Cloud Computing Development and Strategy Forum, and assessed by the Ministry of Telecommunications Research Institute. This assessment is based on the precedents set from real life international and domestic cloud examples. In the third installment of this certification, PaaS capabilities was added to the assessment to ensure a full suite of capabilities while each criteria's evaluation standard increased. There were a total of 50 cloud services that entered this assessment, with a passing rate of 64%. Chinasoft's core product, the PaaS platform RCloud (RCloud Application Engine), successfully received the certification in this installment.

RAE is built on the business application development platform, with focus on enterprise-level cloud that enables the development and integration needs to support SOA application integration system.

Chinasoft's PaaS platform (RCloud), includes cloud application engine services, business process cloud services, cloud message queues, cloud service lines, cloud certification authentication, cloud development platform, cloud application portals and other service module. This model has been used in Li Shui, Hangzhou, Guizhou, and other cities that is building their government cloud on Ali-Cloud.
